Artificial Intelligence...Turning RIM from Administrative Burden to Strategic Advantage

Artificial Intelligence (AI) is poised to significantly reshape the Records and Information Management (RIM) field over the next five years. AI offers transformative potential by enabling organizations to manage records more effectively and comply with evolving legal and regulatory requirements. However, this progress is not without challenges. Issues such as data quality, system integration, and ethical considerations must be addressed to harness AI's full capabilities. Here, we explore AI's challenges, potential uses, and benefits in RIM.

Potential Uses of AI in Records Management and Legal Discovery

Despite these challenges, AI holds immense potential for revolutionizing RIM practices. One of AI's most promising applications lies in automating routine tasks such as data classification, metadata tagging, and records retention scheduling. With applications such as Brilliant's Neural AI eXecutive (NAIX), organizations can reduce manual workloads, minimize errors, and ensure greater consistency in records management practices by automating these processes. The Association for Intelligent Information Management (AIIM) notes that organizations with mature data strategies are 1.5 times more likely to experience enhanced efficiency and decision-making from their AI investments.[1]

AI offers transformative capabilities in legal discovery. Natural Language Processing (NLP) enables AI system to understand and interpret human language, allowing them to search vast datasets more effectively than traditional methods. For instance, AI-powered tools can identify and retrieve relevant records for legal

cases in a fraction of the time it would take using manual methods. This accelerates the discovery process and ensures more comprehensive and accurate results.

TWAIN Working Group announces a new White Paper: The Benefits of Adding JPEG-XL to the ISO PDF Standard and PDF/Raster

As digital document workflows evolve, there is a growing need for more efficient and higher-quality image compression methods. The **PDF** format, while established as the standard for document exchange, has historically been limited by its reliance on older image formats like JPEG, PNG, and JPEG 2000.

This white paper explores the advantages of integrating **JPEG-XL**—a next-generation image compression standard—into the **ISO PDF Standard** and **PDF/Raster**, and how it can unlock new levels of efficiency, quality, and flexibility for modern document management.

If all current JPEGs were delivered as JPEG XLs (with an average 20% decrease in file size), we could save the equivalent to powering 487,000 average US homes for an hour and saving 3,500 metric tons of CO₂ emissions per day.

By integrating JPEG-XL, PDF can evolve to meet the demands of modern digital document management, ensuring smaller file sizes, better image quality, and improved efficiency.

TWAIN Working Group supports the adoption of JPEG-XL into the ISO PDF standard as a crucial step towards modernizing the format and unlocking its full potential for industries worldwide.

Let the bots do the work: Using RPA vs. IDP To Automate Downstream Processes

Over the last few years Robotic Process Automation (RPA) and Intelligent Document Processing (IDP) have converged. In many cases, RPA has all the functionality of IDP players but with a special weapon: attended and unattended bots. Now, technology that can handle everything including Document Understanding, model building, workflow, and the ability to hand off tasks. So why would a systems integrator or customer ever pick IDP over RPA?

Technology has finally made it possible for bots to learn, understand, self heal, and make rational, logical decisions without human intervention. And in cases when human intervention is necessary? These bots know when to involve decision makers. AI Agents have solidified themselves as a viable tool to reduce labor costs by automating repetitive common business processes. And now, bots are capable of controlling screens and can even make API calls directly to any and all applications.

Software robots or RPA can read, understand, translate, and take action all in a single platform. This webinar will be sharing practical uses of Robotic Process Automation (RPA) and leveraging AI decision making as part of the bot's actions. Most of the webinar will consist of various product demonstrations using UiPath

and Microsoft Power Automate to show how RPA can simplify and automate your processes. Additionally, we'll have a brief overview of some of the hundreds of RPA platforms in the market and discuss their differences, pros and cons, and how they are commercially priced and licensed.
